bayernets, Eni Gas Transport Deutschland S.p.A. (Eni D), E.ON Gastransport, GRTgaz Deutschland and GVS Netz merge their market areas with effect from 1 October 2009

Important course for more competition in the gas market

The network companies *bayernets* GmbH, Eni Gas Transport Deutschland S.p.A. (Eni D), E.ON Gastransport GmbH, GRTgaz Deutschland GmbH and GVS Netz GmbH have agreed to merge their H-gas market areas under the roof of Ratingen-based NetConnect Germany GmbH Co. KG (NCG) with effect from 1 October 2009. The successful conclusion of the negotiations thus creates what is by far the largest market area for gas trading in Germany.

In future, gas can be sold across Germany from the North Sea to the Alps and from the river Oder to the Rhine with only one entry- and one exit-contract. Gas shippers and merchants stand to profit alike. The five partners are thus sending a clear signal in support of competition in the gas market. NCG's virtual trading point (VTP NCG) at which gas can be traded across the new market area both bilaterally (OTC transactions) and on the market (energy exchange) will be significantly upgraded, highlighting the European dimension of NCG's VTP and the significant increase in gas trading across national borders.

The high-pressure pipeline system in the extended market area comprises some 14,800 km and ties into more than 400 other gas grids. The new market area handles more than half of the natural gas shipped across Germany.

NCG's business fields include balancing group management and the provision and operation of the "Virtual Trading Point NCG" and a market area information platform on behalf of its shareholders. With Eni Gas Transport Deutschland S.p.A. (Eni D), GRTgaz Deutschland and GVS Netz joining the group of NCG shareholders, the shareholder structure will change as follows: EGT 35 %, *bayernets* 20 %, Eni D 15 %, GRTgaz D 15 %, GVS 15 %.
