The 24/7 contact must be entered in the online registration form:

The entry of the contact details "24/7 availability" are required in accordance with Section 1a (3) GasSV so that the federal load distributor can reach your company at any time in the event of a national gas shortage or to fulfil the obligation to take solidarity measures in accordance with Article 13 of Regulation (EU) 2017/1938, e.g. to send your company decrees in accordance with Section 14 EnSiG or to contact you in the event of queries. In the emergency level, storage withdrawal orders are sent to the email address provided. In the emergency level, it must be ensured that 24/7 availability is guaranteed, as storage withdrawals must be implemented within a short period of time.

When entering or changing contact persons, it is important to note that the entries or changes are only applied once the contact person has given their consent. The user data or the old contact person data will initially remain in place until approval is given. If the new contact person does not give their consent within 14 calendar days, the corresponding change request is automatically discarded.

Once you have completed the registration form correctly, you will receive an e-mail confirming receipt of your registration application. THE will then check the data provided in the form and you will receive a separate e-mail containing the documents required for a successful registration process.

The required documents are:

- 1. The " "Market Participant's power of attorney for the user of the security platform gas", completed in full and signed by the user and an authorised signatory. The authorisation to sign must be equivalent from the extract from the commercial register. If a person who is not authorised to sign is signing, a power of attorney is also required to authorise them to sign. This power of attorney must be issued by a person authorised to sign.
- 2. A copy of the front of the valid identity card of the authorised signatory and the user (all details on the copy of the identity card, with the exception of first name and surname, date of birth, signature and period of validity, must be made unrecognisable before transmission. Failure to make the details unrecognisable will result in the immediate deletion of the copy sent and must be resubmitted. The copy of the ID card should always be sent by post or by fax (to the fax number: + 49 30 364 289-420). If the copy of the ID card is sent by e-mail, it is essential to ensure that the file containing the redacted copy of the ID card is password-protected).
- 3. A current extract from the commercial register (not older than three months)
- If service providers are used, please provide us with the fully completed and signed "Power of Attorney for Service Providers" (<u>https://www.tradinghub.eu/en-gb/Download/Download-center-THE</u>)



As soon as you have submitted the requested documents to us in full by e-mail (<u>sicherheitsplattform@tradinghub.eu</u>) or by post and THE has successfully completed the check, you will be informed that your account has been activated and the corresponding access data will be sent to you by e-mail. Please change the initial password when you log in to the Security Platform Gas for the first time.

When you log in to the Security Platform Gas for the first time, you must also set up twofactor authentication (2FA). To set up 2FA, please install an authenticator application on your smartphone or other mobile devices:

- FreeOTP / FreeOTP+,
- Google Authenticator,
- Microsoft Authenticator,
- andOTP,
- etc.

#### **5** Initiatives

As part of the processing of measures in accordance with Section 1a Paragraph 1 of the "Gassicherungsverordnung", data with regard to the storage user agreements are to be provided by the storage system operators and storage users. This data represents important information for decisions by the Federal Network Agency as the Federal Load Distributor in the event of a gas shortage.

In order to process these measures, a so-called initiative is created in advance on the Security Platform Gas. An initiative is a process on the platform for the procedural handling of a gas shortage. The initiatives that have been created are displayed in the menu item "Initiatives".

After an initiative for a gas day has been created, the previously entered data status in the menu item "Storage facilities" as well as data for the storage user agreements are transferred as a copy to the corresponding initiative by the system and can be supplemented by the storage user after the transfer process has been completed. After double-clicking on the relevant initiative, a new window opens and you have the option to add the data to the specific initiative.



#### 6 Sending of notifications by the Federal Load Distributor

In case the Federal Network Agency as the Federal Load Distributor creates and starts an initiative on the Security Platform Gas, information is sent to the storage users by e-mail. The e-mail is sent from the sender address <u>noreply@Sicherheitsplattform-gas.de</u> to the 24/7 contact person registered in the Security Platform Gas.

The subject and content of the e-mail (notification) are shown below.

## 7 Sending of orders by the Federal Load Distributor

In case the Federal Network Agency as the Federal Load Distributor orders a withdrawal of gas quantities for storage users the order is sent by e-mail to the relevant storage user. The e-mail contains the order as a PDF attachment and is sent from the sender address <u>bundeslastverteiler-gas@bnetza.de</u> to the 24/7 contact person for the Security Platform Gas registered in the THE Customer Portal.

The subject and content of the e-mail (order) are shown below.
